USER AGREEMENT

1. General provisions

1.1. Website - professional Internet resource, representing by yourself totality web- pages available to Users in the address space of the current domain/subdomain , created, V volume number, V purposes conducting and/or informing users Internet resource on educational events held for pharmaceuticals And medical workers, as well as goods, works, services V in the field of medicine and Pharmacy.

1.2. User – an individual – a visitor to the Site, who accesses the Site by means of networks Internet, A Also which own by will And V in his own interest stated wish register on Event/Information activity onproposed Informational resource conditions.

1.3. Event/Information activity - mass online or offline Events, such How interregional And regional scientific and practical conferences And congresses, events federal level, national And international congresses, schools, Seminars And etc., other activities various format,intended for medical and pharmaceutical workers - webinars, surveys, tests And etc., organized And conducted Informational resource And intentionparticipation V which (in one from which) stated User .

1.4. The following persons are allowed to register for participation in the Event/Information Activity:medical and pharmaceuticals employees:

- Pharmaceutical industry workers (pharmaceutical manufacturers)products, pharmacists etc.);
- workers health care;
- scientific employees, working for medical topics;
- doctors;
- interns and residents;
- other adults faces, working V pharmaceutical And medicalindustries.

1.5. Information resource – a company that organizes and conducts Events/Information activities on basis proper powers.

1.6. The User's Personal Account (hereinafter referred to as the Personal Account) is a virtual space User on Site, fixed for By the user V flow 14 days With dates his firstregistration.

2. Item Agreements

2.1. Custom agreement (further - Agreement) - is by agreement accessions And legally binding by agreement, prisoners between By the user And Informational resource.

2.2. Hereby User expresses my interest V participation V Events/Information activities. User by joining To real Agreement And registration on Site orders at Informational resourceservice of the opportunity to participate in Events/Information activities, receive information O such, A Informational resource undertakes such opportunity provide subject to compliance terms of this Agreements.

2.3. User registration for participation in the Event/Information activity without familiarization and acceptance of the terms of the Agreement is not permitted. The Agreement comes into force effective from the moment of registration of the User and extends for an indefinite period, and exactly on period provision to the User access To To the site.

2.4. The processing of the User's personal data is carried out for the purposes of execution real Agreements - by registering on Site For participation V Events / Informational activities, User expresses my interest V offers Information resource.

3. Rights And responsibilities User

3.1. After registration, the User undertakes to independently ensure the safety data access To accounting records Personal office And measures By prevention unauthorized access strangers persons To accounting records. All actions, produced through Private cabinet, are considered produced By the user.

3.2. User undertakes to:

- not to collect, copy, save and distribute personal information data of other Users, regardless of the intentions of use these data;
- do not use the information provided by the Site or Events/Information activities possibilities For any mass mailings - advertising, commercial, propaganda And etc.;
- Not advertise goods or services With purpose extractions benefits - any commercial advertising should be agreed upon With Informational resource;
- Not produce none actions, capable interfere normal functioning Site, conducting Events/Information activities, A Also Not try get unauthorized access To management Site And to commit any actions, available onlyauthorized to the administrator Site;
- not to violate the legislation of the Russian Federation by using any opportunities provided The Site (if the User is located outside outside the Russian Federation, he also undertakes to comply with the law countries stay);
- Not use access To To the site or opportunity participation V Events/Information activities For propaganda or agitation,exciting social, racial, national or religious hatred

or enmity, propaganda violence, social, racial, national, religious or linguistic superiority, distribution unreliable information;

- Not give out myself for other face, How really existing, So And fictional.

3.3. None business, partnership, commercial or advertising activity Users V within the framework Site or Events/Information activities impossible without written coordination with Informational resource.

4. Rights And responsibilities Informational resource

4.1. After the User joins this Agreement Informational the resource provides the User with the opportunity to participate in Event/Information activity for which registration was made, or invitation for participation V which was received from Informational resource.

4.2. Informational resource carries out organization And carrying out Events/Information activities, provides the User with the opportunity access to the Personal Account, allows or restricts access to its users To the site or Events/Information activities, carries out other rights.

4.3. In case of violation by the User of the rules established by this Agreement, access User To his Personal office Maybe be temporarily suspended, blocked, or removed without possibility re-registration.

4.4. At conducting Events/Information activities V format online can any comments or messages from the User may be deleted if they are deemed to be violate rights And freedom third persons, wear offensive, unethical or irrelevant character, do not comply with the Site policy. In these cases, the account (Personal account) User May be removed without any consequences.

4.5. Informational resource Not is engaged consideration conflicting situations And resolution disputes between Users, however leaves for by yourself right suspend a registered User's access to his Personal Account when availability complaints on behavior User, or delete his account (Personal cabinet).

4.6. 4.10. The information resource is not responsible for technical impossibility User register For registration and/or participation V Events/Information activity, any technical failures that do not give possibilities registration and/or participation.

4.11. Informational resource carries out processing data User With compliance with the principles and rules established by the Federal Law of 27.07.2006 N 152-FZ "ABOUT personal data", approved Politics V relation processing personal data, A Also compliance measures, providing their protection from unauthorized access.

5. Terms and Conditions use materials Site, Events/Information activities

5.1. Playback materials Site and/or materials Events/Information activities (further "materials") allowed only V case direct permissions, contained V such materials, at indication on their copyright holder And source borrowings, With active hyperlink on Website and/or internet page Materials/Information activities.

5.2. It is prohibited:

5.2.1. playback materials Site and/or Informational resource without his consent;

5.2.2. using excerpts from materials where the context changes, excerpts acquire ambiguous character or discordant shade, processing material;

5.2.3. any commercial usage materials.

5.3. Informational resource installed separate ban on usage materials based on paragraph 3, part 1, article 1274 of the Civil Code of the Russian Federation in the absence written consent Information resource.

6. Informing User, agreement on processing personal data

6.1.
